MINUTES OF THE MEETING OF BRYMBO COMMUNITY COUNCIL HELD ON TUESDAY 8^{TH} JULY 2014 AT BWLCHGWYN COMMUNITY CENTRE.

There were two amendments to the previous month's minutes. Cllr Birch declared an interest as a member of Brymbo FC and not Brymbo Lodge F.C. Cllr Reston requested that under the heading Councillors annual remuneration, it should be stated that members did not claim an allowance apart from the lighting, footpath and planning reps. The minutes were signed by the Chairman.

3. COUNTY BOROUGH COUNCILLOR'S REPORTS

Cllr Kelly opened by saying that he had attended a site meeting with the Environment Dept. about the grass cutting problems at the Four Crosses junction. WCBC were employing more staff and using more equipment due to the severity of the problem. Cllr Kelly told members that at Llanarmon Road there was a civil dispute between landowners about the right of way. Sean Hanratty at WCBC was also involved. Cllr Kelly said that meetings had taken place over the last month with regards to the future of Bwlchgwyn Community Centre. He said that Hugh Jones at WCBC was committed to delivering this project for the residents of Bwlchgwyn. Cllr Rogers said that he had attended a meeting and had presented his own personal views which were not representative of the CC. He said the issue was that WCBC could not lease the building to the organisation. They needed to clarify ownership and preferred that BCC leased the land to the organisation. Cllr Birch said that WCBC had built the CC on land and therefore they should sort out this problem. BCC should not become involved with this. Cllr Kelly said the way forward was if BCC agreed to become the landowners. He said that there could be an adverse possession order made by WCBC by default and therefore BCC would have no future control over the land. Cllr Woodfine-Jones raised concerns that this was a several steps process, and that if the CC leased the land there would obviously legal costs to be dealt with. Cllr Birch said that this was a difficult situation and there were no deeds and no documentation showing authorisation to build on the land. Cllr Birch said that this matter had been discussed extensively over the last few months and also at the last meeting and he felt that the CC had done everything possible to help the organisation. Cllr Rogers said that any future proposals should be made in writing and this would mean that the item could be placed on the Agenda and discussed at a future meeting. He said that the organisation would need assurances that WCBC would not in future develop the land, and it would be for the use of the community only. Cllr Birch said that this should be the way forward. Cllr Birch permitted a member of the public to address the Council with regards to a public right of way. (Route 12). He said that an application had been made to modify the right of way and that Sean Hanratty of WCBC was involved in the investigation. Cllr Rogers said that he had signed documentation in his role as Councillor for Brymbo, however he did not take part in the investigation. Cllr Monti said that the footpath had never been a bridleway and this had been backed up by previous objections. He said that WCBC insisted it was a bridleway, and were preparing to modify it. Cllr Monti said that the CC should support the local residents in this matter. Cllr Kelly said that if the CC had not made representations previously it would not now be consulted during the investigation. Cllr Birch said that the CC would now wait

for the appeal. Cllr Rogers explained that Sean Hanratty had been appointed by WCBC to deal with the backlog of issues and this is why it had now come about. Cllr Rogers said that the Rev Noel Carter was moving to Llandudno and this would result in changes in the parish. He said that Brymbo and Southsea would split and Brymbo would come under the parish of Minera. Cllr Rogers said that the head teacher of St Mary's school was also moving and he would be going to Penygelli School. He asked that the Clerk write to both the vicar and the head teacher to express their thanks for the good work carried out during their time in the village. Cllr Griffiths advised members that fires had been causing problems during the day on land behind the dance school. Thick smoke had been causing severe problems. Cllr Rogers said he would liaise with WCBC. Cllr Birch said he would also bring this up with the persons concerned.

4. CAMBRIAN HOUSE

Cllr Monti told members that the buyer for Cambrian house had secured tenants for the building. Cllr Rogers said that two windows had been smashed. Cllr Monti said he would speak to the buyers to see if they would get them fixed.

5. ROADS

Cllr Rogers said that the legal documentation for the completion of the Spine Road was due to be signed at the end of the week.

Cllr Rogers said he would like to approach WCBC to provide 4 new grit bins from WCBC in preparation for the winter. Members supported this.

6. BUS SHELTER SERVICES AND STOPS

Cllr Monti said he would contact a local roofer as the bus shelter was still leaking in Brymbo.

7. PLAYING FIELDS AND PLAYGROUNDS

8. FOOTPATHS/LIGHTING

Cllr Kelly said that WCBC were looking into the issue regarding street lights situated opposite the school in Bwlchgwyn. Cllr Woodfine-Jones said that the lights had been installed at the same time as the traffic calming had been carried out. Cllr Kelly said that WCBC had no record of owning these lamps. Cllr Rogers asked if there were numbers on the poles. He said if there were Jones Lighting could see if they belonged to BCC. Cllr Woodfine-Jones said that prior to the upgrade the lamps were the responsibility of WCBC. The Clerk asked if they were on BCC's inventory. Cllr Woodfine-Jones said they were not. The Clerk said that if they were not on the inventory they would not be on the asset register and therefore not on the insurance policy. Cllr Monti said that if they were not on the inventory the CC did not own them. Cllr Kelly said he would be making further enquires.
