3. COUNTY BOROUGH COUNCILLOR'S REPORTS

CBC Kelly wished to thank all residents and Councillors who had help to tidy up the War memorial in Bwlchgwyn prior to the Remembrance service. He said that there had been a large turnout. Cllr Bassford-Barton had circulated a tender for the works that would be needed in the village. The Clerk would circulate this to Councillors to distribute around the village. CBC Kelly said that the Executive Board had met that day and the LDP had been discussed. He said that the Inspector would make the final decision on the site after looking at all three proposals. Cllr Monti asked why the Executive Board could not make an immediate decision as the Brymbo site was obviously unsuitable. CBC Kelly said that once the plan comes before the board any withdrawal would be a fundamental amendment. CBC Rogers verified this and said that a site could not be removed at this stage. Cllr Shone said that in 2009 the same site in Brymbo had been put forward and rejected, yet 8 years later the same site had been put forward again. He said his concern was how WCBC could consider an unsuitable site yet again. He said this seemed like a waste of public money. CBC Rogers said that WCBC still believed that this site was suitable. Cllr Shone said that individuals should write to WCBC under the Freedom of Information Act and ask how much this had cost the taxpayers. Cllr Shone said he was also concerned that money had been spent on sites that were not under the ownership of WCBC. Cllr Mathews asked why WCBC had not simply looked at their asset register first. He said it was gross incompetence. CBC Rogers said that under LDP1 the CBC could look at land not in their ownership. He said that all the sites under consideration would have an airing and an opportunity for dialogue.

CBC Rogers said that the Remembrance service in Brymbo had been excellent. There had been a service and parade which had been well attended. He said he would like to thank Cllr Matthews and Cllr Prince for their work on the War memorial. He said that the donation that BCC had made to the Church had contributed to the excellent exhibition which was continuing that week before moving to the Enterprise

Centre. CBC Rogers said that the car park at Cheshire View had been completed and he had received thanks form Mr Brian Stapley.

CBC Rogers said that concerns had been raised regarding speeding on one side of Tanyfron School. He had spoken to officers however based on previous consultation, allocation of funding had been made and the only option was if the CC would consider funding the legal costs .He asked if members wanted to consider a 20 m.p.h. zone around the school and if so the CC could cover the costs. Cllr Mathews asked if members could have a costing before making any decision. Cllr Ashworth therefore proposed and Cllr Shone seconded that CBC Rogers obtain costings for the project. A vote was taken. All were in favour. CBC Rogers said that he would also like members to look at funding CCTV in certain areas in the future. Cllr Shone raised concerns that BCC were seemingly funding many things at present. CBC Rogers said he would discuss this with Coedpoeth CC as they were undertaking a similar scheme.

10. BVHA

CBC Kelly said that there were concerns by residents regarding the future of the Hall. Denise Garland had not responded to any of the e-mails the Clerk had sent however she had contacted CBC Kelly. She had requested that he attend a meeting with the leader and the deputy leader. There had been further developments with the Charity Commission becoming involved. He said that it could be a matter that BCC would have to fund the legal costs as they had argued that Brymbo Parish Council had failed in their duty allowing the building to be erected on their land. CBC Kelly

said that BCC would need to defend this statement. The Chairman said that BCC would need to take legal advice following CBC Kelly's meeting with officers.

11. BRYMBO VACANCY

The Chairman told members that an election had been called after 10 or more electors had requested one in writing to the Electoral office. However, upon calling the election no-one had applied for the vacancy. The CC could not co-opt as the election had been called therefore the process would need to be run again. The CC would need to fund this from their reserve account.

12. NOTICEBOARDS

The Chairman said that the Perspex on one of the noticeboards needed replacing. He said ASAP sign had done this previously in Tanyfron. He would arrange for this to be done.
