On-going discussions were still going ahead between Brymbo Developments and WCBC regarding the new school and more information would be available in September.

CBC Rogers said that there was positive news regarding Station Road with it reverting back to two way traffic at the end of the month. Discussions were on-going with the developer with regard to widening a section of the road.

Cllr Rogers said that the road re-surfacing budget this year was limited.

6. PLAYING FIELDS AND PLAYGROUNDS

Bronwens Green sub-committee had met to discuss the works needed to bring the pitch and surrounding area up to playing standard as over the last quarter works had not been completed. Cllr Mathews had obtained two quotes for the work needed and members agreed to delegate the overseeing of the work to the sub-committee.

7. FOOTPATHS/LIGHTING

Cllr Rogers had circulated an e-mail to all members prior to the meeting explaining why the cost of the light on railway road had increased as requested at the previous meeting.

8. WAR MEMORIAL

Cllr Rogers said that basic maintenance for the Brymbo War Memorial was needed. He requested permission to obtain quotes for the work . Cllr Mathews proposed and Cllr Ashworth seconded that he obtain quotes for the work. A vote was taken. All were in favour.
