3. COUNTY BOROUGH COUNCILLOR'S REPORTS

CBC Kelly told members that an announcement was due imminently with regards to the settlement form Welsh Government. He said that it could be devastating. The report on the Boundary commission was due soon and this could result in a change in the wards. CBC Kelly asked if he could have an agreement to tidy up the War Memorial in Bwlchgwyn before remembrance Sunday as there was some damage to the wall that needed attention. Cllr Steele proposed and Cllr Bassford-Barton seconded that the work be done immediately. A vote was taken. All were in favour. CBC Kelly said that he had received complaints regarding signage in the village. He reminded members that any signage had to be authorised by WCBC before placing on Council owned land.

CBC Rogers said that he and other members had attended the public consultation event by Brymbo Developments. Cllr Ashworth had told the company that it was an inconsiderate time for working residents and they had said they would take this on board for the future. Cllr Shone pointed out that there had been no proposals merely drawings. CBC Rogers said that unfortunately the consultation would only allow comments on certain aspects of the development. Cllr Shone said that it was imperative to get the infrastructure in place first as this would have a significant effect on the area and residents. Concerns were raised regarding the Ty Cerrig development as it was outside the settlement but fully developed on the plan. CBC Rogers said that Brymbo Developments had not listened to the advice CBC officers

had given them. Cllr Ashworth said that she was very worried about the development of the school. CBC Rogers said that they had moved the proposed school site from the original plans. He said that there were big gaps in what Brymbo Developments had done. He said that WCBC would be pressurising them to complete the school site. CBC Rogers informed members that Blast Road at the rear of Argoed had been sold to a holding company and there was a provision for 70 dwellings. He said that there was a need for housing for elderly people. He said that the lagoon site had also been sold and this would be looking at a range of mixed ownership dwellings. Both sites had planning permission.

CBC Rogers said that the off-street parking on Offa Street was near completion.

7. FOOTPATHS/LIGHTING

The Clerk had forwarded numerous e-mails that had been received from Jones Lighting with regard to the survey and replacement lamps. The Clerk had received costings for the work needed

Undertake survey of existing lighting stock, 369 lamps at a cost of 7.34 per lamp=2708.66

Supply and install indo LIGHTS, 369 lamps @189.33 per lamp =69863.16 Supply and install ASD LED lantern, 369 lamps @ 217.27 per lamp =80172.93 E/o over Scaffold works (to be charged where scaffolding is required to access the street lighting column 57 lamps @ 36.70 per lamp =2092.05

Cllr Mathews proposed and Cllr Prince seconded that BCC go ahead with replacing the lamps with ASD LED lanterns and obtaining the survey and re-numbering of the lamps needed. A vote was taken. All were in favour. The Clerk was to e-mail Jones lighting to advise.

8. WAR MEMORIAL

CBC Rogers said that some work was needed on the Brymbo War Memorial before Remembrance Sunday. He said that the Heritage Group had advised him that there were names missing from the memorial and these had been verified. He asked members if they would agree to get costings for the new plate and to tidy up the area before the next meeting. Cllr Mathews proposed and Cllr Monti seconded that permission be granted to carry out any work needed. A vote was taken. All were in favour. CBC Rogers advised members that the time of the Remembrance Service had been moved this year. He said that there would be a service at the Methodist Chapel at 10.15 a.m. followed by a parade to the War Memorial. The Archdeacon would then take the service at the War Memorial.

9. PLANNING

No planning applications had been received.

10. BRYMBO VACANCY

The Clerk had informed Electoral Services about Cllr Clarke's resignation. Adverts for the vacancy would be placed the next day in Brymbo for 14 days

11. QUARTERLY ACCOUNTS

The Clerk circulated copies of all income and expenditure for the second quarter of the financial year. The Chairman and Clerk signed the bank reconciliation.
