Again as per last month ASB Nuisance majority are the issues with Brymbo Sports and Social Club Body Camera Footage has been taken at the incidents to identify the youths and a list has been made and circulated to all PCSO in the area, again home visits have been made to numerous address in Brymbo, Brynteg, Southsea and Gwersyllt all parents agree that the actions of their child is unacceptable. A meeting has been conducted with Housing Enforcement Officers, Youth Workers and School Liaison Officers. Visits have been arranged with these Officers. North Wales Police have spoken to just over 15 youths and issued over 20 Yellow Cards and follow up letter have been sent by the Youth Workers.

A meeting has been conducted at the Brymbo Cricket Club with members of the Committee and myself and Sqt Luke Hughes.

Youth Workers have received the relevent inforamtion from NWP and areengaging with them.

PCSO Jones introduced the new PCSO Tim Edwards who would be taking over from him.

Cllr Ashworth and the Chairman thanked PCSO Jones for all his work in the community and said that he would be missed as he had made a significant impact in the area.

3. COUNTY BOROUGH COUNCILLOR'S REPORTS

CBC Kelly said that there were issues with potholes, gulley's etc. and that Street scene had been advised.

CBC Rogers had been informed that a planning application was due imminently for the Lagoon site.

CBC Rogers had been approached by WCBC with an offer to fund a 20 foot container for outdoor provision for the Youth provision currently being funded by BCC. He said that WCBC had requested that BCC cover the cost of the planning application and concrete base for the container. CBC Rogers asked for members support to take up the offer from WCBC, and also asked if they would support him and Cllr Prince in increasing the size of the container from 20 foot to 40 foot and that BCC pay the difference in cost. He said that the Youth provision was going well. Cllr Prince said that as many as 20 youths attended the project and it was well received in the village. Cllr Ashworth proposed that BCC in principle look at funding the cost of a 40 foot container on condition that a quote be obtained and brought back to full council for members to consider prior to making a decision. Cllr Bassford-Barton seconded the proposal. A vote was taken. All were in favour.

10. BVHA

CBC Kelly told members that a meeting had been arranged with the Leader, Deputy Leader and Denise Garland of WCBC to discuss BVHA on Friday the 11th January at 10.00 a.m. The Clerk updated members and said that she had referred their case to the Council's insurance company who had been in contact with her before the Christmas period. All the documentation she had, had been sent to them. After speaking with them on the phone the legal advice was that no-one should attend any meetings with WCBC at present. The legal advice was that WCBC should correspondent with BCC in writing, in order that each party was clear in what was being discussed. At present, everything that the CC had been told had been passed on verbally. CBC Kelly said that the Charity Commission had become involved after Denise Garland of WCBC had consulted with them. Members said that if the Charity Commission had any issues they should come directly from them and not through WCBC. These issues should also be made in writing to the Clerk. Cllr Shone proposed that no-one attended the meeting scheduled for the end of the week following the legal advice given and that the Clerk request that all correspondence be directed through her in order that she could distribute to all members of BCC. Cllr Steele seconded the proposal. A vote was taken. All were in favour.

11. INDEPENDANT REVIEW PANELS REPORT ON TOWN AND COMMUNITY COUNCIL'S IN WALES.

The Chairman advised members that the WA would not now be taking the proposals from the report forward.

12. CLERKS ANNUAL SALARY REVIEW

The Chairman requested that the Clerk leave the room. Upon her return the Chairman said that the Clerks pay increase would be in line with SLCC pay scales and annual increments as in previous years.

13. RISK ASSESSMENT

The Clerk had circulated copies of the Council's risk assessment to all members prior to the meeting. Members had reviewed the document. Cllr Rogers proposed and Cllr Mathews seconded that the risk assessment be approved. All were in favour. .

14. TANYFRON VACANCY

The Clerk had been advised by Electoral Services that an election had not been called. She requested that the co-option notice be placed in Tanyfron for 14 days.

15. BWLCHGWYN TENDER

The Clerk had received the tender bids. The applications were assessed on price and on the tender specification. Members discussed the applications and felt that one tender mirrored the original tender specification that the Councillors for Bwlchgwyn had agreed. Each item was itemised on this application and members felt that this answered all the tender requirements for Brymbo Community Council. It was therefore proposed by Cllr Steele and seconded by Cllr Shone that this tender would be accepted at a cost of £1478.00 per annum. A vote was taken. The motion was carried.

16. NEW MODEL STANDING ORDERS.

The Clerk had circulated the new model standing orders that were to replace the 2013 version prior to the meeting. Members agreed unanimously to adopt these. The Clerk said she would circulate official copies for members at her earliest convenience.
