PCSO Simister brought a colleague from the roads policing unit who had been monitoring traffic along the new road. Complaints had been received about the excessive speed along the stretch of road and a high visible patrol had been set up. The unit had issued many tickets in one day. Cllr Rogers said that the police had been very recognisable in their efforts and thanked them for their work. Residents had been reassured by the police presence. All information would be fed back and dealt with. A new initiative was being set up by the police where volunteers were

requested to participate in training with hand held devices in their areas and all these findings would be looked at and acted upon.

#### 3. COUNTY BOROUGH COUNCILLOR'S REPORTS

Cllr Rogers said that with regards to the Housing Renewal Scheme the finance from the Welsh Government was not enough to fully complete the project. Residents were due to be informed. Cllr Rogers advised members that the café at the Enterprise Centre was due to close however a new operator had been sought and would be taking over soon. The gym at the centre was closing however this was a decision taken by the owner. Cllr Kelly said that a slight problem had emerged with the refuse collection the previous week in Bwlchgwyn as a result of works being undertaken by Dee Valley Water. This had now been resolved.

#### 4. FINANCIAL UPDATE

The Clerk circulated copies of the budget for the year and the expenditure for each category to date as requested by the Internal Auditor. Members said that spending was in line with the budget set for the first six months. The Chairman noted that the energy costs seemed slightly high for the lamps at the Tanyfron MUGA and the Clerk said she would monitor this as the first invoice had come after the winter.

#### 5. ROADS

Cllr Rogers asked Darren Green from WCBC why traffic management had been in place on High Street in Brymbo since the previous Saturday however no work was being carried out by the Housing Renewal team. Mr Green said that he would contact Housing Renewal and advise them again that traffic management was not to be erected until the work was ready to begin. He would request that the traffic management be removed.

## **6. BUS SHELTER SERVICES AND STOPS**

Cllr Rogers said that the Arriva service through Tanyfron was being kept however the service through Lodge was to be stopped the next month.

#### 7. PLAYING FIELDS AND PLAYGROUNDS

The sub-committee of Bronwens Green had met during the summer and numerous issues had been dealt with. A quote had been obtained for removing shrubbery and to erect a fence and remove the gate. Cllr Prince and Cllr Mathews would now meet the maintenance contractor to finalise the works.

#### 11. BWLCHGWYN CROSSING

Dave Hesketh and Darren Green from WCBC attended the meeting to discuss the road crossing in Bwlchgwyn. The Chairman opened by saying that Bwlchgwyn were due funding from the CC for a project in their village and Bwlchgwyn Councillors would discuss with the residents group all options available. Cllr Woodfine-Jones said that a young boy had been hit by a van the previous week and had suffered a serious injury. He said the road by the Kings Head was hazardous for children crossing to and from school on a daily basis. Cllr Kelly said that there were multiple concerns and issues. He said there were options available from school crossing patrols to traffic calming that would need to be discussed with the officers from WCBC before any decision was made. He said that the residents group could decide what they needed and they would be able to discuss in more detail with WCBC. A school crossing patrol would cost approx. £3500.00 per year and would have to be funded by the CC as WCBC no longer funded these, however they would still manage them. A risk assessment would be needed .Dave Hesketh said that a crossing patrol would probably not meet their criteria for the area in question however an option of interactive signs in and out of the village was possible, as would new road markings. These would cost approx. £3000.00 each. Casualty history would be looked at if these were preferred. WCBC would work alongside BCC to gain positive solutions for all concerned. Dave Hesketh and Darren Green said they would be happy to attend the Bwlchgwyn residents group to discuss the project in more detail. Mr Green said that the speed limit of 50 mph was being reduced in the village and other speed reductions were imminent in Bwlchgwyn. The Chairman said that Bwlchgwyn councillors and the residents group along with WCBC officers would discuss this further and would come back to the CC with a decision. The Chairman thanked both Dave Hesketh and Darren Green for taking the time to attend the meeting outside their working hours.

## 12. BRYMBO LUNCHEON CLUB GRANT APPLCATION

The Clerk had received all the financial documentation for the grant application to pay for the insurance on the minibus. Members felt that they should see the quote and requested that the Clerk contact Mrs Stapley in order that they could discuss it at the next meeting.

# 13. REFURBISHMENT OF STEELWORKS MONUMENT AND MAINTENANCE OF ST MARY'S CHURCH CAR PARK

The car park at St Mary's Church was in need of tidying up as it was an eyesore. Cllr Birch proposed and Cllr Woodfine-Jones seconded that a quote for the work needed would be sought from the maintenance company who cared for Bronwens Green. All were in favour. Cllr Rogers said that the monument at the steelworks site was in need of repair and cleaning. It had deteriorated over the years and now posed a health and safety threat. Cllr Birch proposed and Cllr Jones seconded that a quote for the work be obtained. A vote was taken. All were in favour. Cllr Rogers said he would organise this.

# 14. PLANTER EDWARDS AVENUE

The Clerk had received an e-mail from Di Ashworth requesting permission to place a wooden surround and add an engraved plaque to the planter on Edwards Avenue in memory of Mal and Ken. Members agreed that this would be a touching gesture and agreed. Cllr Rogers said he would contact WCBC to make sure no permission would be needed.
